God clearly articulated His message about humanity at the moment of our creation. He said, "Let us make man in Our image, according to Our likeness" (Genesis 1:27). He didn't utter those words about any other form of life. And with this declaration, it was so.

Christians accept other doctrinal mysteries on faith—*You are in Christ, God has chosen you, you have been saved, the free gift of God is eternal life in Christ Jesus our Lord*—so it's not out of the ordinary that we would be expected to believe that all of mankind is made in God's image.

**B**eing made in God's image means we can have a relationship with God, communicate with Him, steward the earth, and much more. But it's very important to remember that bearing God's image is

not dependent on a person's ability to perform any or all of those functions.

For instance, a human being at any age bears God's image despite the fact he may be unable to communicate. Similarly, a person has dignity and inestimable worth even when she does nothing but lie helplessly in bed. The most vile of sinners, existing in unrepentant opposition to God, also bear His image and have value and dignity. How do we know? Because God declared it.

Significant Bible passages speak of mankind as being made in the image of God even after Adam and Eve's fall:

- Genesis 5:1-3 describes the pattern of procreation: Adam was made "in the likeness of God." His descendants were begotten "in his own likeness, and after his image," which means all of his offspring have also been made in God's image.
- After the Flood, God protected fallen mankind from wanton violence by instituting the death penalty. The rationale God gave for killing killers was the very thing that makes human life special. He told Noah, "*Whoever sheds man's blood, by man his blood shall be shed; for in the image of God He made man*" (Genesis 9:6).
- In James 3:8-12, God gave a similar reason for not using words as weapons: the people you want to curse have been made in the likeness of God.
- Psalm 8:3-8 describes fallen mankind as still possessing "glory and honor."
